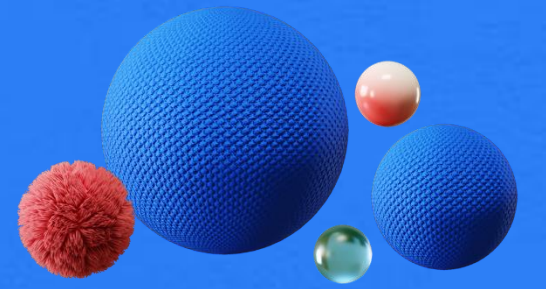

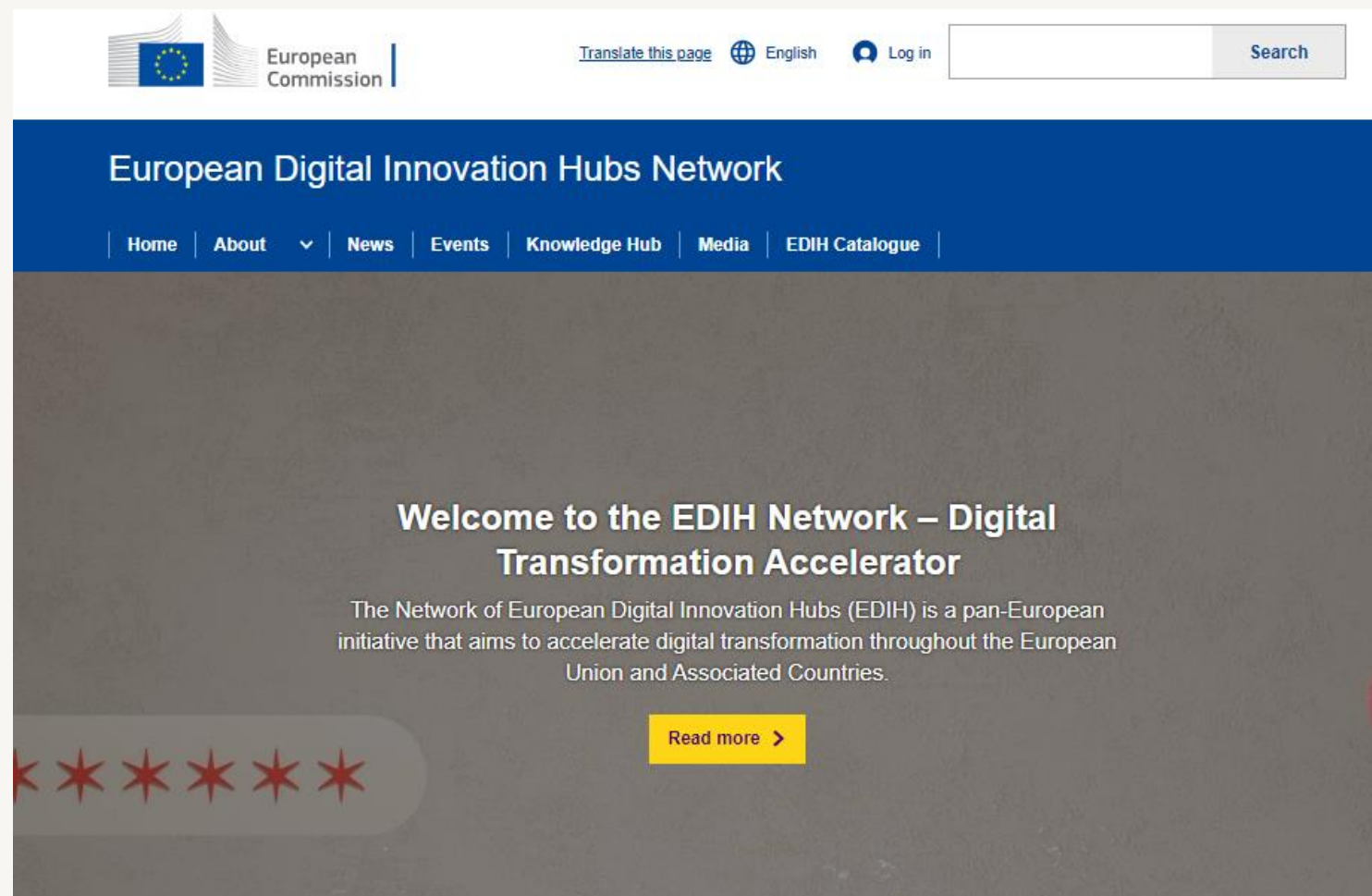

Main access point to information and services

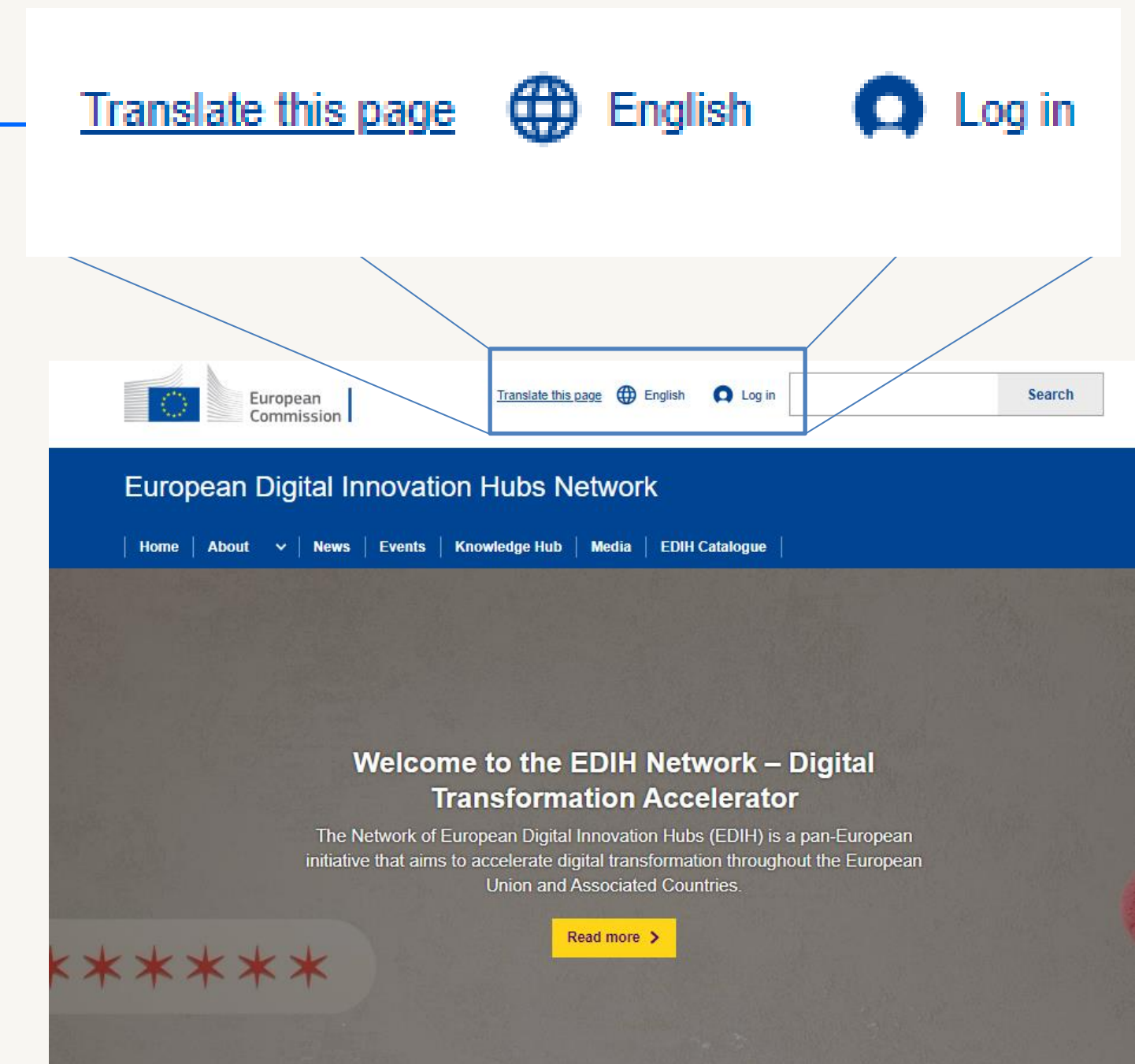

DTA Services for the EDIH Network - Platform

EDIH Network Online Portal

- EDIH Network Online Portal is the central point for providing DTA services to EDIHs and other stakeholders.
- The EDIH network portal has a **private area** for logged in users (EDIHs) providing a series of tools and functionalities.
- Initially, only EDIH Coordinators have granted access. They are then able to grant access to their partners. All EDIH users have the same rights and power in the platform.

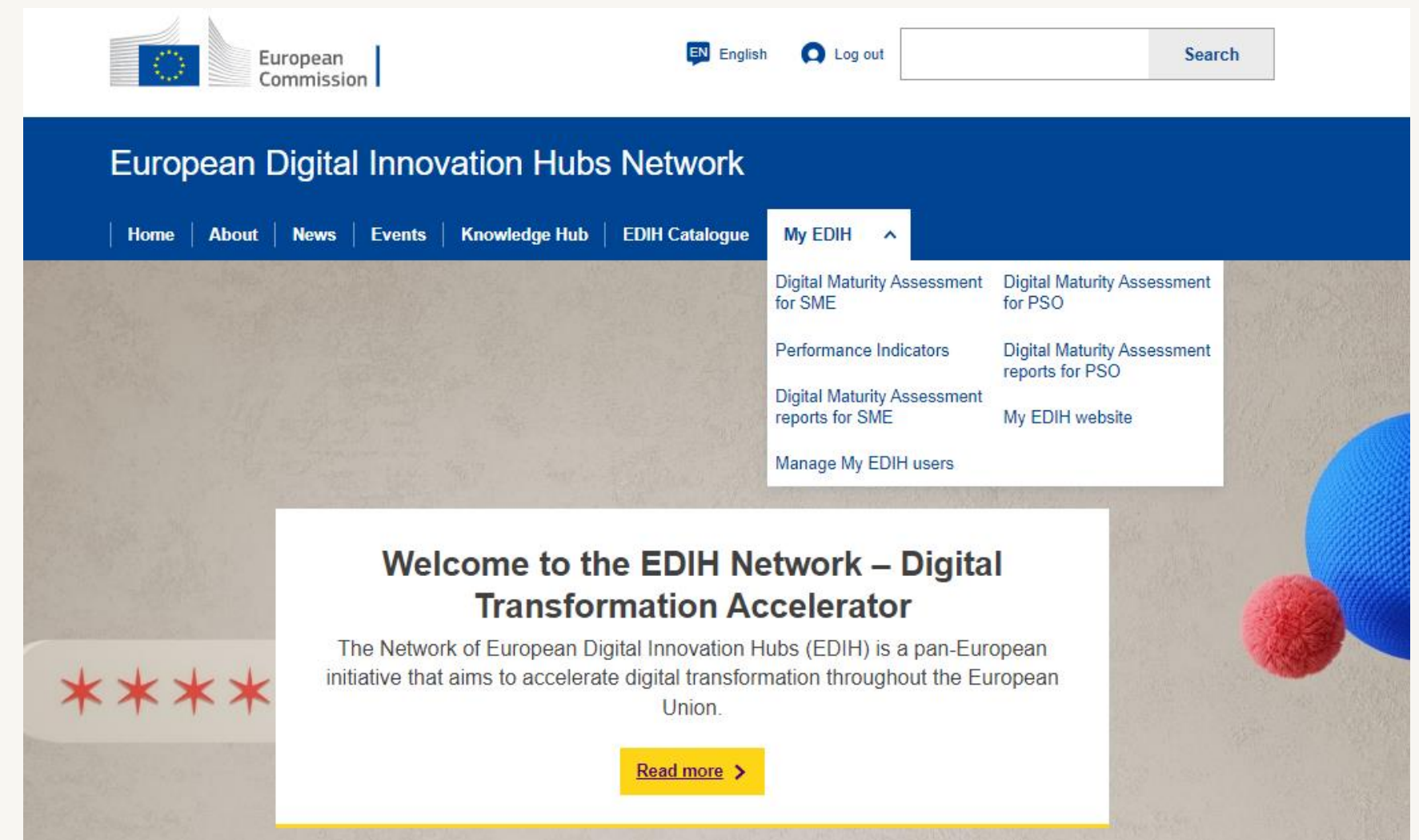

My EDIH space

➤ The “My EDIH” space is only visible to logged in users of the EDIH Network portal.

It contains:

- DMA Tool for SME and PSO
- DMA reports for SME and PSO
- KPI reporting Tool
- My EDIH website (EDIHs “mini-sites”)
- Manage My EDIH users

My EDIH space – Digital Maturity Assessment tool

DMA MANUAL, FAQs & WEBINAR CAN BE FOUND ON KNOWLEDGE HUB/GUIDANCE DOCS SECTION

The DMA is a framework that assesses the overall digital maturity level of EDIH customers (company or PSO) over 6 dimensions:

Small and Medium-sized Enterprises - SMEs (and midcaps)	Public Service Organisations - PSOs
<ul style="list-style-type: none"> • Digital business strategy • Digital readiness • Human-centric digitalisation • Data management • Automation & Intelligence • Green digitalisation 	<ul style="list-style-type: none"> • Digital strategy & investments • Digital readiness • Human-centric digitalization • Data management & security • Interoperability • Green digitalisation

To assess the impact of services delivered, EDIHs need to fill the DMA on behalf of the customers three times:

- ❖ T0: max 6 months prior to EDIH support start.
- ❖ T1: 1 year after T0
- ❖ T2: 2 years after T1

Where can I access the DMA Tool?

The DMA Tool is available in the “My EDIH” section of the EDIH Network online platform, which EDIHs can access when logged in.

What is available?

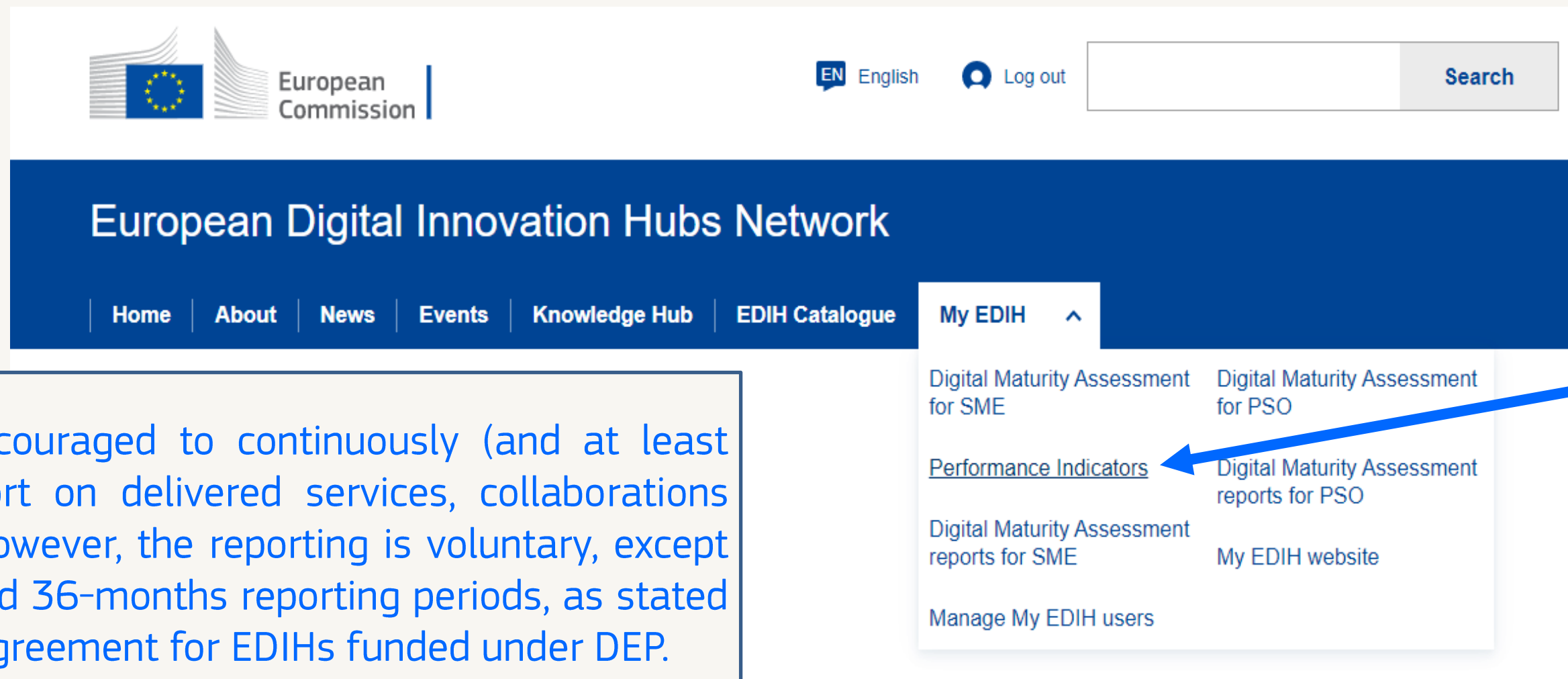
The full versions of the DMA Tool are now available– both for company and PSO assessments.

The DMA reports for SMEs and PSOs are also available on a separate tab: enabling EDIHs to review and filter average results across targeted sub-group of customers.

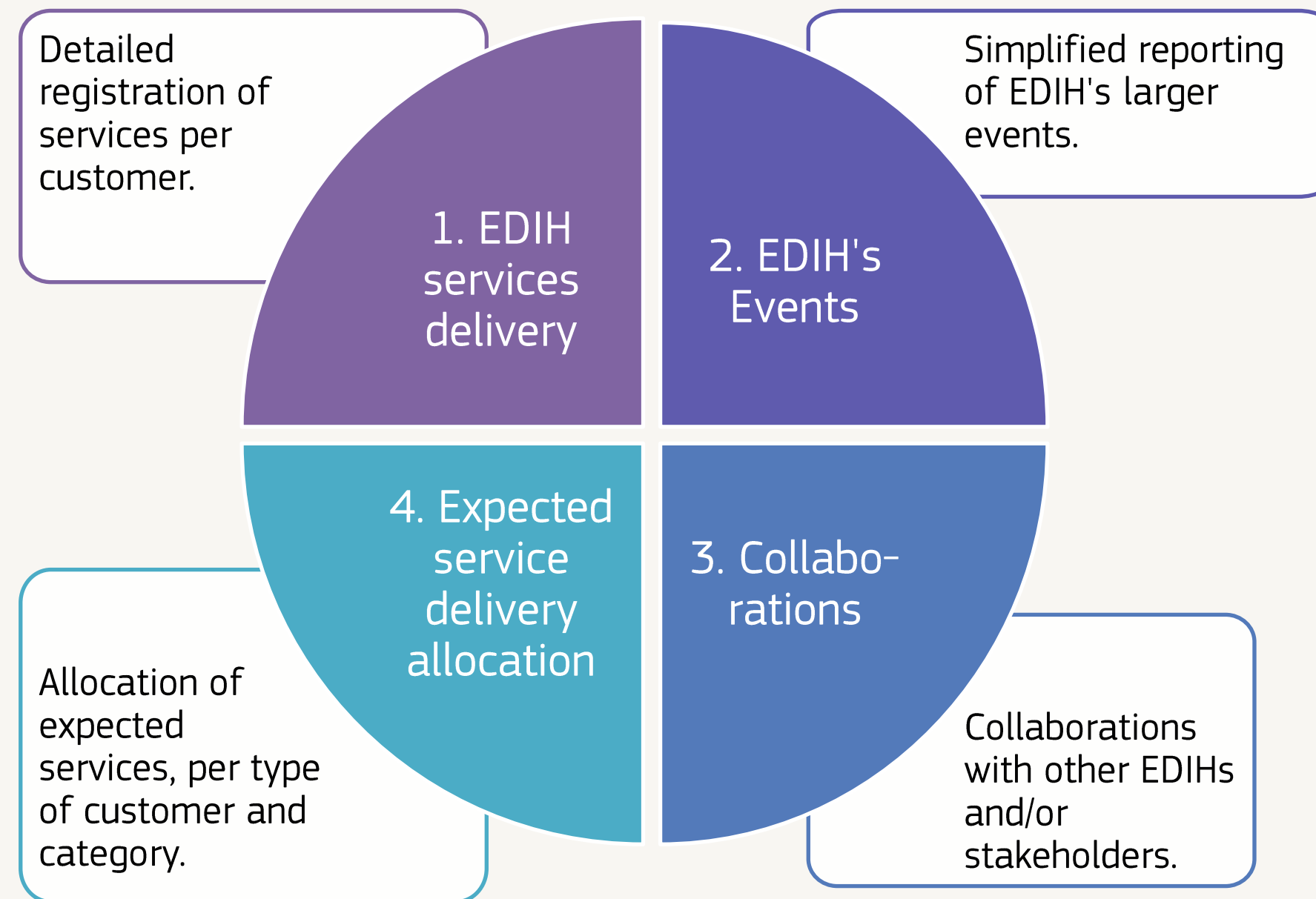
EDIHs are encouraged to continuously (and at least monthly) report on delivered services, collaborations and events. However, the reporting is voluntary, except for the 18- and 36-months reporting periods, as stated in the Grant Agreement for EDIHs funded under DEP.

The Performance Indicators Tool is a self-reporting tool available on the EDIH Network platform under “My EDIH” section.

The reporting tool handles 4 main types of data.

It has been **developed to help the EDIHs** to monitor the service delivery.

→ The tool helps the EDIHs to **fulfil their reporting requirements** towards the European Commission through a standardised method.

→ On the other hand, aggregated data on KPIs will be used by the DTA to assess the degree of target achievement and performance of the EDIH Network.

My EDIH space – EDIH “Mini-sites”

EDIH WEBSITES GUIDE CAN BE FOUND ON KNOWLEDGE HUB/GUIDANCE DOCS SECTION

- EDIH “Mini-sites” are sub-websites located within the main EDIH Network online platform.
- Using a master template, EDIHs can freely edit and publish content on their individual “mini-sites”.

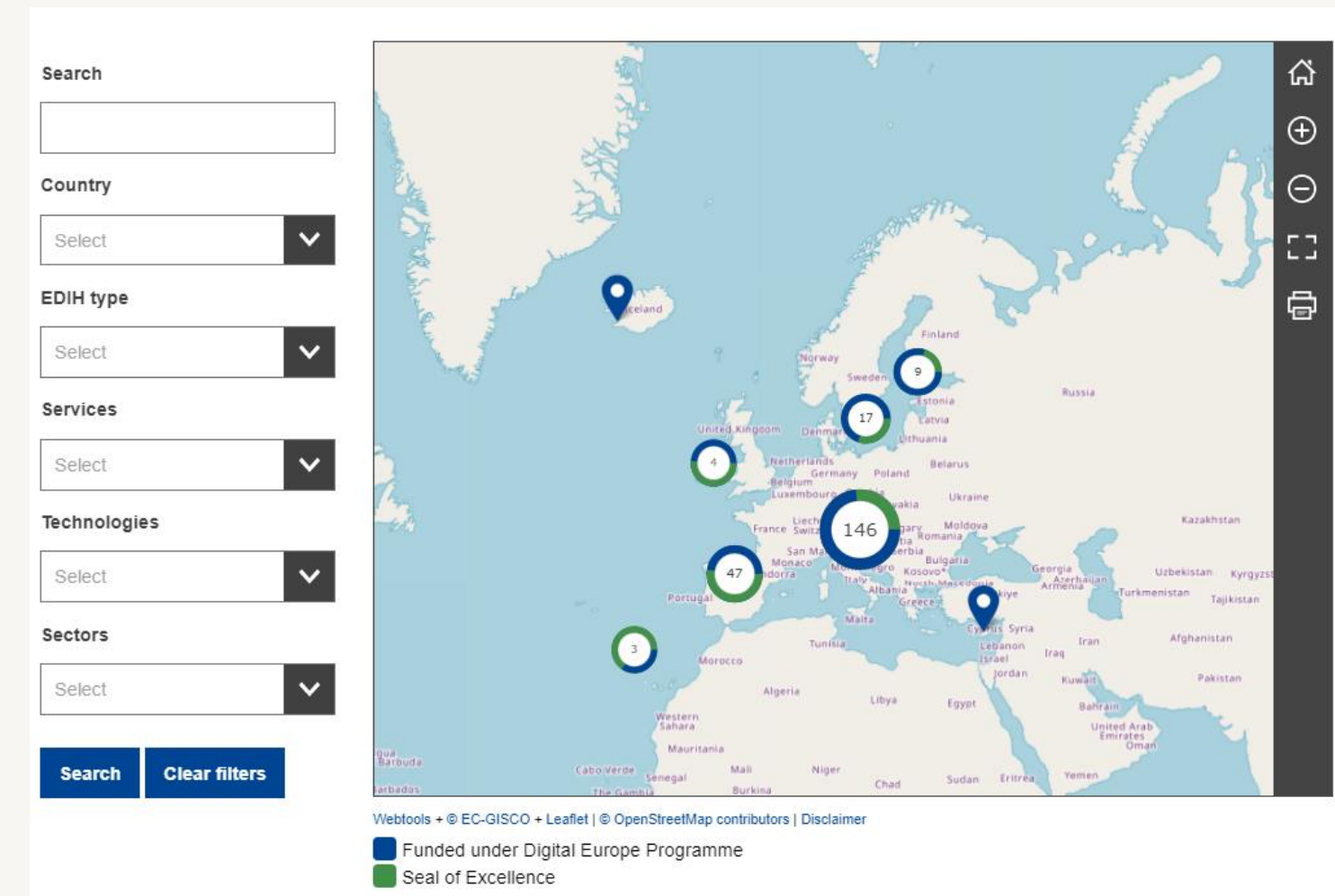
Features:

- **Home page:** offers key information on your EDIH and links to the other sub-sections of your EDIH website
- **About:** introduce your EDIH, its mission, goals, objectives, activities etc.
- **Services:** a listing of the services you provide to your SMEs and PSOs.
- **News:** functionality allowing you to publish news items
- **Events:** functionality allowing you to publish events
- **Collaborations:** information on your EDIH's collaboration network and opportunities for partnerships
- **Contact:** provides contact details
- **Twitter feed:** presents a latest tweets feed from your EDIH's Twitter account
- **Newsletter signup:** provides a link to your (third-party) newsletter signup form

DTA Services for the EDIH Network – Platform

EDIH Catalogue

- The interactive online directory of all European Digital Innovation Hubs.
- Used for identifying EDIHs in a specific region/country, technology field, sector, service provided, keywords etc. through filters.
- It is built upon the pre-existing European catalogue of DIHs.
- EDIH profiles (basic information, description, contact details, services, technological expertise, sectors, etc) can be modified at any time, by logged in users.

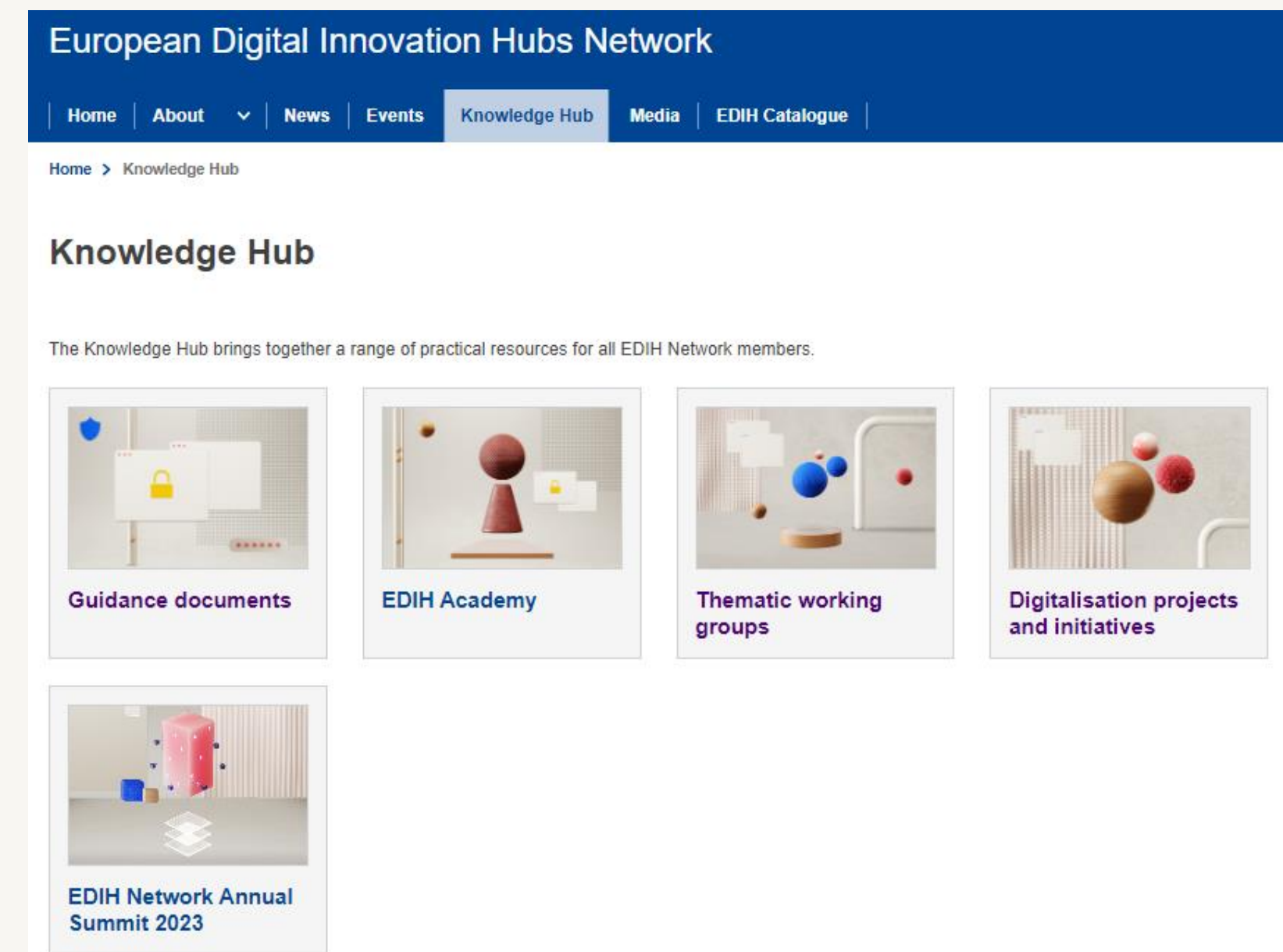

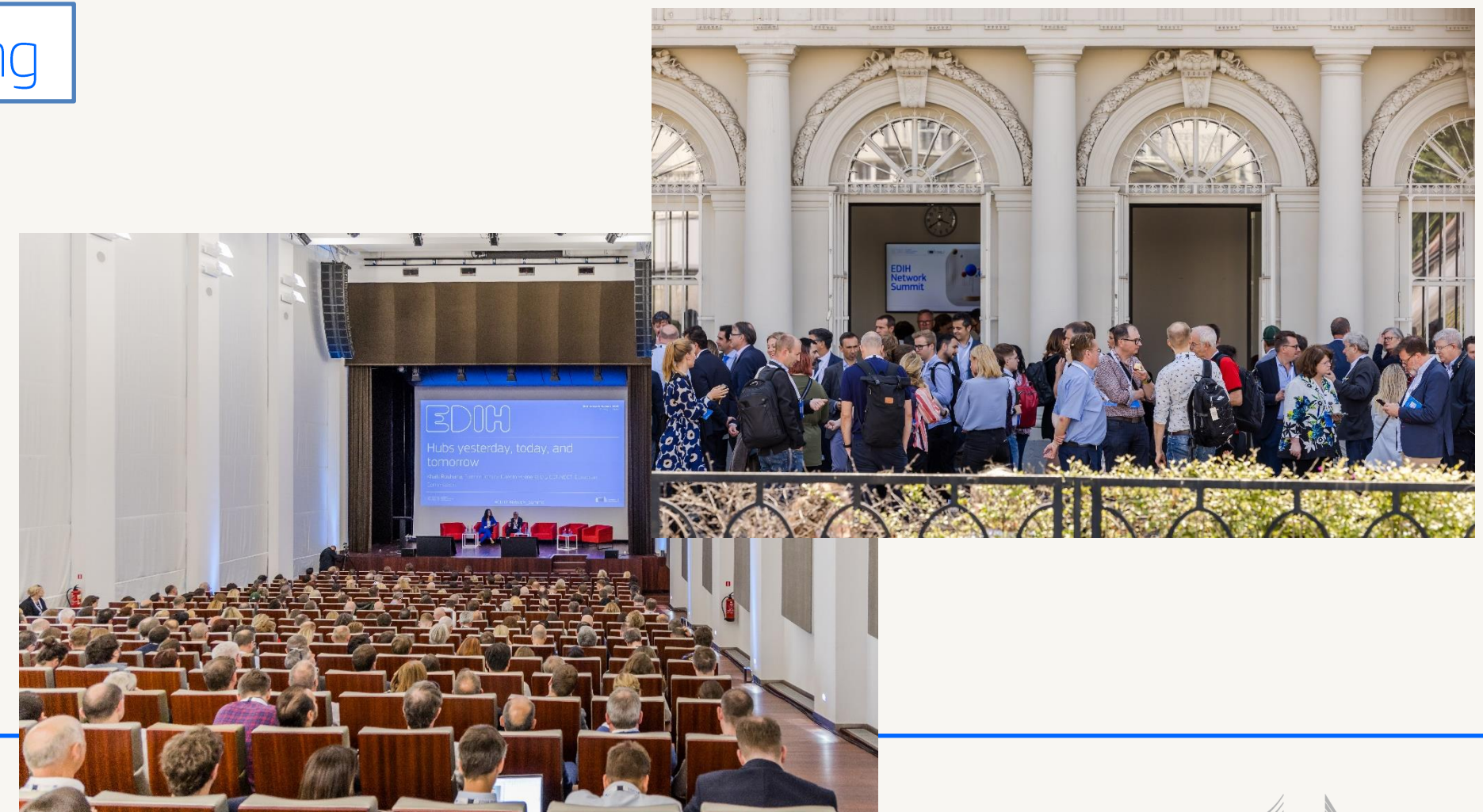

Goal

 - Ensure the development of excellent proposals.
 - Provide guidance on how to submit a proposal under Digital Europe programme
 - Facilitate the integration of newcomers into the EDIH Networks activities

DTA Services for EDIH Candidates in Digital Europe's Associated Countries

➤ Proposal stage

- 1-on-1 proposal pre-checks for eligible applicants
 - Review will be done at least 15 days before the submission date to give applicants the time to fine tune their application
 - Reviews will target the Technical proposals (Part B)
 - Please note: for financial and administrative matters please refer to the Help Desk function in the Funding & Tender Portal

➤ Proposal stage

- Info sessions
 - DTA will provide insights on the services available that are of relevance for the preparation of proposals:
 - EDIH catalogue
 - DMA
 - KPIs
 - DTA will invite experienced EDIHs to share some advice on their do/don't at proposal stage.

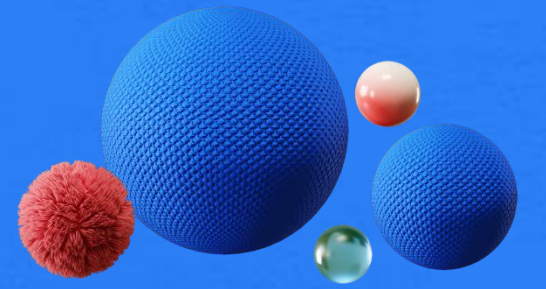
➤ Implementation stage

- “Fast Tracking” for selected EDIHs AC (after the selection process).
 - DTA will offer dedicated support to selected EDIH participants to bring them up to speed and facilitate their integration into EDIH Network activities. This will include:
 - Dedicated webinar series on EDIH Network available tools and resources (Portal, Catalogue, Training offer, DMA, KPI Monitoring, etc)
 - Dedicated support through the DTA Help-Desk
 - Mentoring session with established EDIHs to be organized by DTA
