






The setup of EDIHs




Distribution of EDIH partners by type






Networking patterns between EDIHs

Strong linkages exist between the EDIHs, specially at national level:


- 28% of EDIHs organizations participated in past ICT EU projects

The EDIH projects are financed by 50% from Digital Europe Fund, while the remaining 50% are covered by contributions from the national, regional or local level.




