

CO-FUNDING | RRP

According to Article 6 of Order N.º 12046/2020, of December 11th, which approves the Regulation of the Process of Recognition of Digital Innovation Hub and their Access to the European Network:

 "Access to public funding for digital innovation hubs that are part of the National Network is ensured with national management funds from the European Union Recovery and Resilience Instrument, complemented, where necessary, with European Structural Investment Funds for the period 2021-2027."

Component 16 "Enterprises 4.0" of the Portuguese <u>RRP</u>, the TD-C16-i03 Investment "Catalysis of the Digital Transformation of Companies" includes the support for Digital Innovation Hubs with **a budget of 60M€**, to increase the scale of each of the DIH that will be part of the European Network.

The national DIHs selected for the European network that go beyond the budgetary coverage of the DIGITAL Programme are financed by RRP (75% cofunding) and by private financing of the DIH itself (remaining 25%).
