The columns in the CSV file, must be **comma separated**.

In Import SME and Import PSO the multivalued field *Other sectors*, the values must be separated with ';'.

In Reporting of EDIH services delivery the multivalued field *Technology type used*, the values must be separated with ';'.

In Reporting of EDIH's events the multivalued field *Main related Sector(s)*, the values must be separated with '|'.

In Reporting of EDIH's events the multivalued field *EDIH Co-organiser*, the values must be separated with '|'.

In Reporting of EDIH's events the multivalued field *Main related Technologies*, the values must be separated with '|'.

In EDIH Collaboration the multivalued field *Name of Collaborating EDIH*, the values must be separated with '|'.
